

Maryland HOME Act (SB 530/HB 231)

Housing Opportunities Made Equal Sponsors: Sen. Smith; Del. Lierman

"A family's source of income should never be used as a basis to discriminate against them."

- former US Department of Housing and Urban Development Secretary Shaun Donovan.

How It Helps

The HOME Act prohibits landlords and other property owners from discriminating against persons seeking housing based on their "source of income."

Source of income means any lawful source of funds used in the rental or purchase of housing. It includes money from:

- any lawful employment
- any government or private assistance grant, loan, or rental assistance program
- any gift, inheritance, pension, annuity, alimony, or child support
- any sale of property.




Five Things to Know

- 1. Over 16 states and the District of Columbia have similar laws.
- 2. Howard, Montgomery, Frederick, Prince George, Baltimore, Anne Arundel Counties in MD, the Cities of Baltimore and Annapolis have laws prohibiting source of income discrimination.
- 3. Unused/denied vouchers are inefficient and prolong homelessness.
- 4. We've been fighting for this bill for **20+ years**—but things are changing.
- 5. 2020 could be the year for housing justice!

Why We Fight!

Senior citizens, people with disabilities, single mothers, veterans, and lower wage workers are all disproportionately affected.

- 60% of voucher households rely on SSI, social security or pensions
- 59% of voucher households include wage or income earners
- 39% of people who benefit from vouchers are children
- 42% of voucher households are single mothers with children







Common Misconceptions

This legislation does NOT:

- Stop landlords from verifying source and amount of income, evaluating income stability or tenant history and suitability.
- Dictate how much landlords can charge for rent
- Prevent landlords from refusing income that comes from criminal activity
- Slow down or prevent housing and economic development.

Expungement Expansion (HB 1343)

Sponsor: Del. Mosby

"Never be a prisoner of your past. It was just a lesson, not a life sentence."

Why do we support expungement expansion?

- An estimated 1.5 million Marylanders, nearly 25% of the state's population, have a criminal record that may surface in a routine background check.
- A criminal record can serve as an insurmountable barrier to getting a job, housing and other critical resources, even if the record did not result in a conviction.
- Streamlining criminal record expungement can significantly improve opportunities for housing and employment.



What does this bill do?

- Allows expungement of misdemeanor convictions after 3 years
- Expands expungement eligibility to some felony convictions
- Makes civil offenses/infraction convictions eligible for expungement after 3 years
- Allows expungement of convictions for second degree assault, common law battery and domestically-related crime after 5 years
- Makes invalidated warrants eligible for expungement
- Adds expungement eligibility for "probation before judgment" DUI rulings after 3 years



Expungement Works!

We have seen firsthand the impact expungement has on the people we serve.

- Without these services, many are left without limited options and become increasingly vulnerable.



• 70% of homeless youth report experiencing some form of violence, 32% of which includes sexual assault.

• 40% of homeless youth are victims of sex trafficking at least once in a single year.



Why might it be difficult or impossible for youth to obtain parental consent?




The Solution: HB 206/SB 207

This bill allows for unaccompanied minors to consent to admission to emergency shelters or housing programs/services.





Only eight states have passed a similar bill





So why do we support this bill?

- 1. Youth not connected with family face significant barriers to housing services
- 2. Obtaining parental consent for housing, health care or other services is not always possible for youth experiencing homelessness
- 3. Providing housing and supportive services to youth is a critical step toward ending their homelessness

4. Our mission is to end homelessness for ALL

Overdose Prevention Sites in Maryland (HB 464/SB 990) Sponsor: Sen. Hettleman

Fight for harm reduction to save lives!

What are Overdose Prevention Sites?

OPS are indoor spaces where people can consume their own drugs with immediate access to life saving interventions, medical care, emotional support and non-judgmental therapeutic relationships.



Five Reasons We Fight for OPS

- 1. Reduce deaths from drug overdose
- 2. More than 2,100 people DIED from opioid overdose in 2018 in Maryland
- 3. People who use drugs are asking for an OPS
- 4. Consistent with the principles of harm-reduction
- 5. Evidence-based model of care
 - Reduces risk of arrests, lowers rates of infections such as HIV and Hep C, pushes back on the war on drugs and mass incarceration that disproportionately target people of color



Five Things to Know

- 1. More than 150 OPS exist around the world
- 2. A federal judge ruled these programs do not violate the law
- 3. A Baltimore study estimated that a single OPS would save the health care system \$7.8 million each year
- 4. Arrests and incarceration don't work addiction is a public health issue, not a criminal issue
- 5. This bill has been introduced for the past five years, but the issue is gaining momentum and needs our help to elevate it further
